ECONOMIC DEVELOPMENT



Skinner Blvd construction has progressed to east-bound

Downtown Projects

- **Mid-Town Parking Garage** – A selection committee will be choosing vendors for this project this summer.
- **Skinner Blvd Road Project** – FDOT is planning to open the north side and close the south side of Skinner soon for construction. Scheduled to be completed in the spring of 2026.
- **Downtown Streetscape Paver Enhancements** – This initiative will improve walkability and overall aesthetics on Main Street from the Pinellas Trail to Broadway. Scheduled to begin in summer of 2025.
- **Main Street Exchange** – Mazas Management submitted a design review application for Main Street Exchange, a mixed-use project. The plans involve retail, luxury apartments, and chef-driven kiosks. Bill Mazas plans to present an update of the project at the May 7 CRAAC meeting.
- **Former City Hall** – The next step is to complete the design specifications and go out to bid this summer. This will also be discussed at an ARC meeting on May 6.

Community Redevelopment Agency (CRA)

- The CRA Advisory Committee is scheduled to meet **May 7**.
- The CRA Mid-Term Review is being presented to the CRA on May 22.

- **Coca-Cola** - Staff continues to meet regularly with Coca-Cola to assist with the redevelopment of the property.

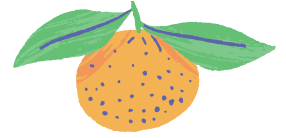

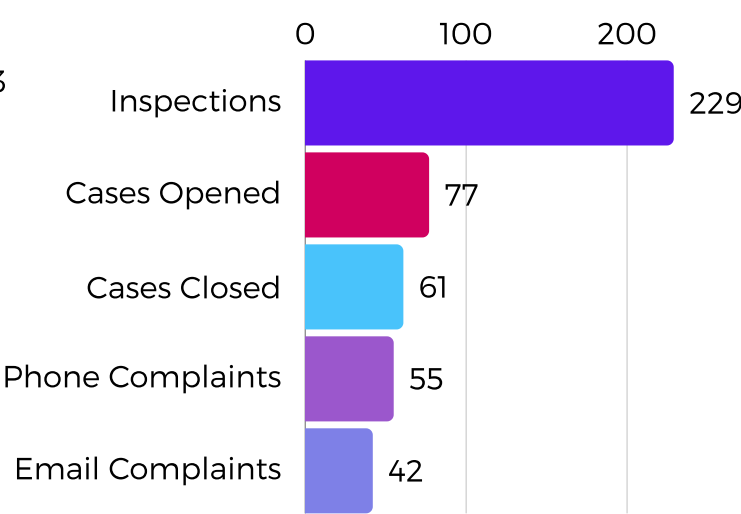

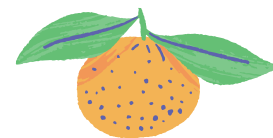
Kudos!
