ECONOMIC DEVELOPMENT



Skinner Blvd roundabouts are designed to enhance safety and improve traffic flow from Main Street to Broadway. Features include bike lanes, bus bays and a multipurpose path connecting to the Pinellas Trail

Downtown Projects

- **Mid-Town Parking Garage** – A selection committee is reviewing the RFQ respondents for this project
- **Skinner Blvd Road Project** – The road section of the project has been completed. The undergrounding of utilities and landscaping is scheduled to be completed in the spring of 2026
- **Downtown Streetscape Paver Enhancements** – This initiative will improve walkability and overall aesthetics on Main Street from the Pinellas Trail to Broadway. This project is due to begin in the summer of 2026
- **Main Street Exchange** – Mazas Management submitted a design review application for a mixed-use project with retail, a boutique hotel, chef-driven kiosks, and a garage. (The garage is being planned for the nearby, former art incubator location.) The parking garage portion of this project is being presented to the ARC on September 9
- **Former City Hall** – The project went out for bid this month (September). Construction is scheduled for this winter

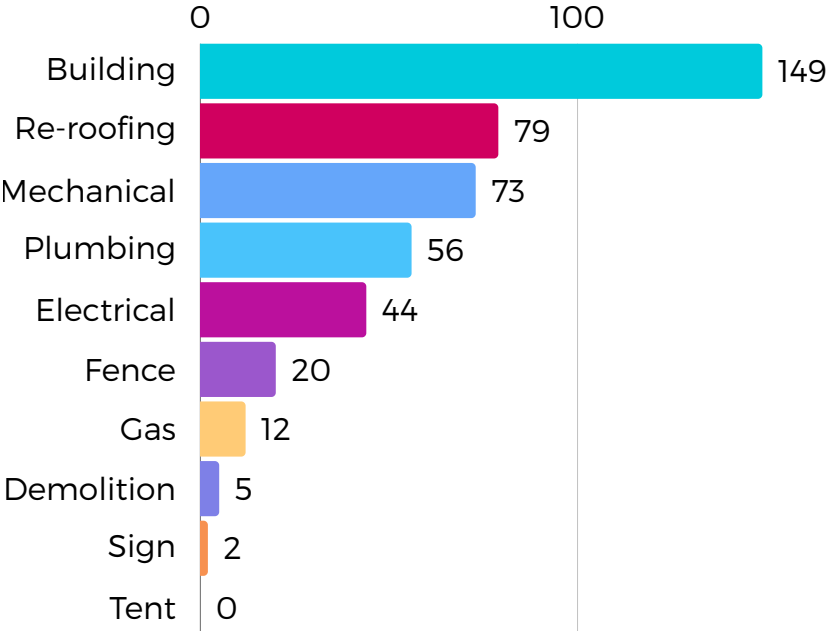

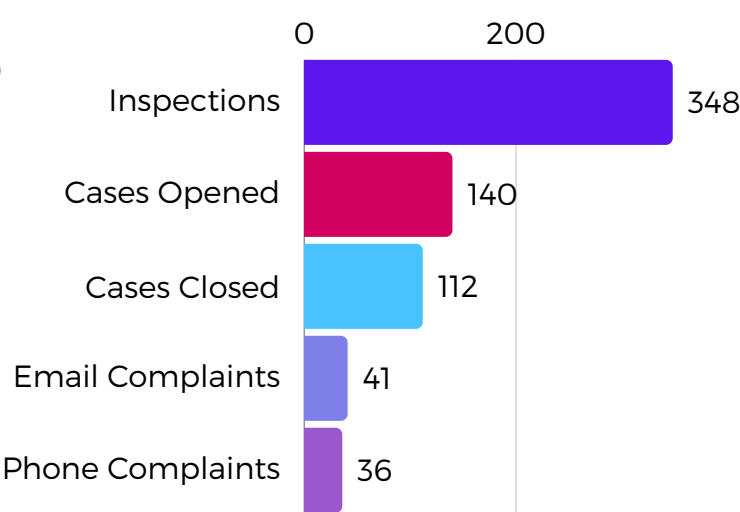

PUBLIC WORKS

Operations

 - This policy mandates that all employees follow recycling guidelines according to our single-stream recycling partner. A lunch and learn is recorded for others to learn more.
