

Dunedin Public Library is the oldest library in Pinellas County. Library service began in Dunedin in 1895 with a donation of 200 books from the personal collection of Christopher Bouton.

In order for our library services to excel for future generations, it is essential that the assets of our library be nurtured so we can continue to meet the needs of our community.

The Dunedin Public Library Foundation, Inc. was formed in 1992 as an agency for the collection of tax deductible contributions for the enhancement of the Dunedin Public Library. The purpose of the Foundation is to augment City funding so that the Library's collection, facilities, equipment and services will be first class.

The Foundation is not an agency of the City of Dunedin. It is exclusively controlled by its volunteer Board of Directors, all of whom are committed to the Library. The decisions on how the Foundation's funds are used are made by the Board of Directors following a consultation with the Library Director.
